PROJECT SUMMARY

The Bidding and Award phase of the project is rapidly moving forward. The design team members (see Attachment A for team) continue to actively participate in this final phase before construction commences.

CURRENT STATUS

Highlights

- Per the bid schedule, the bid documents were made available to bidders on October 16. On
 October 21, Savin held a pre-bid meeting with CSArch and CCSD. Bidders participated in a walkthrough of the project site, and were given the opportunity to ask questions to clarify the scope.
 Savin and CSArch are putting together an addendum to answer questions received from
 potential bidders.
- The bids will be opened on November 4, and the CCSD Board of Education will award the contracts on November 13. There will be a project kick-off meeting on November 18, with construction mobilizing on November 19. The project is on schedule to be complete by June 26, 2015.
- **CS**Arch and Savin have prepared a Request for Proposal (RFP) to solicit consultants to provide Construction Materials Testing and Special Inspections services during construction. Proposals are currently under review. A recommendation to the district is forthcoming.
- **CS**Arch and Clarkstown Central School District are preparing a Request for Proposal (RFP) to solicit consultants to provide Air Sampling services during construction.

PROJECT REPORTING

The next Project Status Report will be delivered on November 7, 2014.

PROJECT OVERVIEW

Based upon the February 4, 2014 approved referendum, the scope of work for the Congers Elementary School reconstruction includes the following:

- 1. Reconstruction of the original (1927) Gymnasium wall.
- 2. Reconstruction of the north and east walls of the original construction (1927).
- 3. Select ADA accessibility upgrades at the main floor level.
- 4. Partial window replacement (1956/1970 wings).
- 5. Replacement of approximately 23,000 square feet of existing roofing.

BUDGET

Based upon the total authorized budget of \$6.5 million, this would provide \$5,200,000 for construction and \$1,300,000 (20%) for standard incidental expenses. Incidental expenses include professional fees, administrative expenses, testing, legal fees, insurances, etc.
